

is that it cannot assist those whose disability impairs performance so that even with reasonable accommodation they will not do the job as well as someone without that disability. This problem requires positive action, which is not mandated by the ADA. However, while the book does not discuss what is not in the Act, it is good on what it does contain. It is also very lively and very positive. No doubt recalcitrant employers will be able to avoid employing people with disabilities if they are determined to. But people of goodwill who want to see an improvement in the position of people with disabilities and to play their part in assisting that end will find plenty of ideas and encouragement in this collection.

With the growth in the number of non-native English speakers studying law as undergraduates in British universities and of European Law students on one-year study placements, the need for specialized language material is growing. This is probably truer in a subject like law where all language skills are at a premium: oral fluency to participate in seminars, tutorials, moots, debates, etc; an ability to read and understand complex texts, to skim material for relevance and to scan for gist; writing skills for examination and dissertation purposes; good listening comprehension to take accurate notes during lectures. And perhaps more than in any other discipline, the foreign student contends with lexical and conceptual problems, having no equivalent references in his/her own language.

Despite the obvious need to gear language acquisition to the specific requirements of legal studies, there are at present few books available, whether in English for foreign students or in major European languages for English-speaking students on placement abroad.
