

Sample Club Constitution and By-Laws

New and emerging student clubs can use this example when developing a constitution and bylaws specific to their club needs. Established clubs can use this when updating or changing their bylaws.

ARTICLE I: NAME & PURPOSE

Section A: Name – The name of this club shall be UNICEF

Section B: National Affiliation – If the club is a member of a national or state organization, add the following statement and attach a copy of the national constitution as it will become part of this document: "The rules and regulations of the National Constitution shall be followed when not inconsistent with the rules and regulations of CBU."

Section C: Purpose – The purpose of this club shall be:

1. Raise awareness for children and allow them to receive health care.
2. Fundraising at the University of Kentucky so children no longer die from preventable causes.
3. Providing immunizations, safe water and sanitation, nutrition, education, and emergency relief for children.
4. To get UK students involved in UNICEF.

ARTICLE II: MEMBERSHIP & DUES

Section A: Eligibility - Membership shall be open to all students at the University of Kentucky upon payment of the dues as outlined in Section C.

Section B: Dues – Dues shall be \$__3__ per year.

ARTICLE III: OFFICERS

Section A: Officers – The officers shall be a President, Vice-President, PR and Marketing, and Treasurer.

Section B: Eligibility – Officers must be full-time students, carrying at least 12 credit hours.

Section C: Election – The officers will be elected by majority vote.

Section D: Term – Officers will continue to run organization until re-votes are made or until officers graduate.
