- Increased the compensation for trustees and debt limits for Chapter 13 debtors.
- Provides for adjustments in dollar amounts based on the Consumer Price Index.
- Recognizes bankruptcy fraud as a crime.
- Small business investment companies not eligible for relief in bankruptcy.
