Complaint (1st pleading allowed in RPEC) – a pleading alleging the plaintiff and/or the claiming parties' cause/s of action

Complaint

- a. Personal Circumstances – Plaintiff and Defendant
- b. Cause of Action – Under Rule 2 Section 2 RoC A cause of action is the act or omission by which a party violates a right of another.
- c. Environmental Law – it must be stated as to what environmental law is violated
- d. Environmental Case – specify that it is an environmental case

Ratio: So that it will be given priority and will not undergo ordinary raffle. It will immediately be referred to the executive judge

- e. Relief/s Prayed for – state what do you want so that the court will award it to you. Ex. Moral damages/liquidated damages/ atty.'s fees.
