

## COMMERCIAL LAW CASE BRIEFS

**CASE:** KWETEY v. BOTCHWAY AND ANOTHER [1980] G.L.R 722

**FACTS:** The plaintiff in the original suit, Otema Botchway's, boat engine broke down. She thus took a loan from the Agricultural Development Bank, (ADB) the first defendants, which she secured by mortgaging her house. As part of a general exercise, the bank rehabilitated all the broken down engines of all fishing vessels belonging to its customers and gave such customers the first option of paying whatever balance was outstanding or have the boat sold to someone else. On 9<sup>th</sup> February 1978, the A.D.B. wrote to the plaintiff asking her to pay a balance of €149,775.01 which was outstanding on the boat and gave her up to the end of February to settle. Unfortunately, the plaintiff never received this letter. Meanwhile, the second defendant, Cecilia Kwetey, (counterclaimant) through contacts made by her uncle and on her own behalf with the Manager of the Bank had submitted an application to the A.D.B. expressing her desire to purchase one of the rehabilitated vessels to be sold by the bank. The A.D.B. in March offered the plaintiff's boat to Cecilia Kwetey at a price of €150,000 and gave her two (2) weeks to settle.

In the meantime, the plaintiff's solicitor approached the bank about his client indebtedness and was informed by the bank that a letter had been sent to her asking her to pay her debt and that her failure to do so had compelled the bank to offer the boat to another person. Pleading for time to pay her debt, the bank asked the plaintiff through her solicitor to wait till the expiry of the deadline given to the counterclaimant before her request could be considered. The expiry date given the counterclaimant expired and the bank received payment from the plaintiff. Not long after the plaintiff had settled her debt, the bank also accepted payment from counterclaimant for the same boat and instructed that the boat should be released her.

**PROCEDURE:** The plaintiff on learning about this instituted an action against the bank, the Boatyard Division of the Ghana Industrial Holding Corporation and the counterclaimant, for a declaration, inter alia, that the sale to Kwetey was null and void, Kwetey on her part counterclaimed for a declaration of title to the boat, recovery of possession, perpetual injunction against the plaintiff and the bank as well as specific performance and damages for loss of use of the fishing vessel. Ultimately, the court made an order releasing the boat to the plaintiff. On receipt of the boat, the plaintiff discontinued her action against the defendants, but Kwetey decided to proceed with her counterclaim, in spite of the fact that the bank had repaid into her account, the whole purchase price of the boat.

**ISSUES:** Whether the bank had right in the property of the boat to warrant its disposal

ii) Whether the bank by accepting payment from the plaintiff had waived the terms of the contract by forbearance
