- Deductive vs. Inductive Reasoning
  - **Deductive:** predict results if a certain premise is correct (general to specific)
  - **Inductive:** Derived generalizations from a large number of specific observations (specific to general)
- Scientific Theory:
  - Broad and well substantiated theory for some aspect of the natural world that is consistent with available evidence
    - EX: all species are descended from a common ancestor
- Hypothesis:
  - Proposed explanation for an observed phenomenon that is based on knowledge and consistent with available evidence
    - EX: there are no polar bears in the Antarctic because there is no feasible route to get there
  - **Experiments test hypotheses**
