

# ANTI-CORRUPTION POLICY



LEMBAGA PEMBIAYAAN PERUMAHAN SEKTOR AWAM (LPPSA) adopts a zero-tolerance policy towards any forms of bribery and corruption in performing its duties through ethical and efficient manner, accountability, transparency and shall strive to prohibit bribery, corruption, conflict of interest including facilitation payment and unethical practices. This policy statement is to affirm that LPPSA works with integrity and does not tolerate any forms, attempts or activities in relation to bribery and corruption.

## LPPSA is committed to:

- Comply with the provision of MACC Act 2009, MACC Act 2009 (Amendment) 2018 and the applicable law by inculcating integrity, transparency and accountability in all aspects of its businesses;
- Preserve the culture and good image of integrity by providing, practicing and maintaining a working environment free from bribery and corrupt practices whether in daily operational activities or in any project management for all employees and stakeholders including business associates and/or other external parties;
- Conduct a comprehensive corruption and bribery risk assessment to mitigate such risks by ensuring that adequate procedures have been established and implemented.
- Create a framework within the business environment to set, review and achieve the Anti-Corruption Policy objectives to comply with the Anti-Bribery Management Systems (ABMS) objectives;
- Encourage transparent and ethical conduct with undertaking appropriate due diligence processes on employees, business associates and in projects or in business activities;
- Provide mechanism to all employees and stakeholders to raise concern in good faith and to report on bribery and corrupt practices via LPPSA's whistleblowing channel in line with the Whistleblower Protection Act 2010 (Act 711) without fear of retaliation or reprisal;
- Maintain, and periodically review the effectiveness of the policy, its objectives and shall continually improve the LPPSA Anti-Corruption Plan effectiveness; and
- Establish an independent integrity function imposing appropriate action to any party proven to be guilty of being involved in bribery and corrupt practices.

LPPSA shall ensure the board members, employees, stakeholders and any party who performs works or services for or on behalf of LPPSA to engage, read, understand and comply with this Policy. Non-compliance with or violation to the Policy may result in disciplinary action by LPPSA in accordance with its policies, procedures, directives and guidelines and/or initiation of legal proceeding against those involved.
