Unit 10 Guide Company Finance I

Context

There are two basic ways in which a company raises capital: by issuing shares and by borrowing. Usually a company is financed by a combination of the two. Legal advice is normally essential for any financing activity undertaken by companies.

Finance raised by issuing shares is often referred to as equity finance, reflecting the underlying fact that shareholders are the owners of the company. Finance from loans, or debt finance, as it is sometimes known, essentially involves a contractual arrangement between a borrower (the company) and a lender (usually a bank or other institutional lender). As owners, shareholders stand to benefit if the company is profitable by sharing in surplus profits by way of dividends and from any capital appreciation in the value of their shares. Alternatively, if the company performs badly, they may lose their investment entirely due to the fact that shareholders rank behind creditors for the repayment of their capital and on a winding-up, if there are insufficient funds to pay the creditors in full, the shareholders will get nothing.

An issue of new shares is governed by a number of statutory rules designed to ensure fairness between shareholders and to prevent the directors abusing their power to allot shares. Shares can be categorised according to the rights as to voting, income and capital which attach to them.

In this Unit we will look at two of the most common types of shares, ordinary shares and preference shares, and the rules relating to their issue. We will also consider the advantages and disadvantages of each type of investment, namely equity and debt financing, from the perspective of all those involved.
