

 Phoenix spent \$60 on shirts. Purple shirts cost \$24, and green shirts cost \$12 each. How many of each shirt did she buy?
Solution:
 Step 1:
 Define variables: let x be the number of purple shirts and y be the number of green shirts.
 Step 2:
 Set up equations: The total amount spent on shirts is \$60.
 $24x + 12y = 60$
 The total number of shirts bought is 7.
 $x + y = 7$
 Step 3:
 Solve the System of Equations.
 3.1 Solve the second equation for x .
 $x = 7 - y$
 3.2 Substitute x into the first equation.
 $24(7 - y) + 12y = 60$
 3.3 Simplify and solve for y .
 $168 - 24y + 12y = 60$
 $-12y = -108$
 $y = 9$
 3.4 Substitute y into $x = 7 - y$.
 $x = 7 - 9$
 $x = -2$
Step 4: Check the Solution:
 Verify that the answer fits a word exactly both equations:
 $24(-2) + 12(9) = -48 + 108 = 60$ (Total amount spent on shirts).
 $-2 + 9 = 7$ (Total number of shirts).
Step 5: State the Solution:
 Phoenix bought 0 purple shirts and 9 green shirts.
